1. This Invitation to Bids follows the Procurement Advertisement (PA) No. *Tender # FP-3351* for the procurement of **SUPPLY, INSTALLATION, COMMISSIONING AND TRAINING OF NICKEL-PLATING BATH FOR INTAGLIO PRINTING PLATE MAKING**.
2. The PAKISTAN SECURITY PRINTING CORPORATION (Pvt.) Ltd (PSPC) has reserved the funds for the procurement planned during the financial year 2024-25. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
3. PSPC now invites sealed bids from eligible Manufacturer / Suppliers to acquire **SUPPLY, INSTALLATION, COMMISSIONING AND TRAINING OF NICKEL-PLATING BATH FOR INTAGLIO PRINTING PLATE MAKING** that meet the following eligibility criteria:
 - a. *This invitation for Bids is open to all original Manufacturers / Authorized Agents / Supplier of Foreign manufacturers in Pakistan.*
 - b. *Bidders should not be under a declaration of ineligibility for corrupt and fraudulent practices issued by any Government (Federal, Provincial), a local body and international or a public sector organization.*
 - c. *In case of local agent, they must be registered with Income Tax and Sales Tax Department and must appear on the Active Tax Payers List of FBR.*
 - d. *Firms in litigation with the Employer shall not be permitted to participate in this process.*
 - e. *An affidavit (on non-judicial stamp paper) to the effect that the bidder has never been black-listed by any previous employer.*
 - f. *An affidavit (on non-judicial stamp paper) to the effect that all documents / particulars / information given with this qualification Documents are true.*
 - g. *An affidavit (on non-judicial stamp paper) to the effect that the bidder has never indulged in corrupt, fraudulent or collusive practice for procuring contracts.*
4. The bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
5. All bids must be accompanied by a Bid Security in an acceptable form. The amount of Bid Security shall be **2%** of the total value of bid.
6. Tender documents containing the General Conditions of Contract including technical details / specification etc., are available on PSPC Pvt. SECTION II: INSTRUCTION TO BIDDERS (ITBs)

Section II. Instructions to Bidders (ITBs)

<u>A. Introduction</u>	
1. Scope of Application	1.1. The Procuring Agency (PA), as indicated in the Bid Data Sheet (BDS) invites Bids for the equipment and related services as specified in the BDS and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to supply and install the equipment within the specified period and timeline(s) as stated in the BDS.
2. Sources of Funds	2.1. Source of funds is referred in Clause-2 of Invitation to Bids.
3. Eligible Bidders	<p>3.1. A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or of any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.</p> <p>3.2. The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.</p> <p>3.3. Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.</p> <p>3.4. Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.</p> <p>3.5. The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national</p>



	<p>incorporating agency or statutory body established for that particular trade or business.</p> <p>3.6. Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process.</p> <p>3.7. A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:</p> <ul style="list-style-type: none">a. are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of goods and related services to be procured under this Invitation for Bids.b. have controlling shareholders in common; orc. receive or have received any direct or indirect subsidy from any of them; ord. have the same legal representative for purposes of this Bid; ore. have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process; orf. Submit more than one Bid in this Bidding process. <p>3.8. A Bidder may be ineligible if –</p> <ul style="list-style-type: none">a. he is declared bankrupt or, in the case of company or firm, insolvent;b. payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property;c. legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or

	<p>partial loss of the right to administer and dispose of the property;</p> <p>d. the Bidder is convicted, by a final judgment, of any offence involving professional conduct;</p> <p>e. the Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration.</p> <p>f. The firm, supplier and contractor is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for the period defined by them.</p> <p>3.9. Bidders shall provide to the Procuring Agency evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively.</p> <p>3.10. Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request.</p> <p>3.11. Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged.</p>
<p>4. Eligible Goods and Related Services</p>	<p>4.1. All the goods and related services to be supplied under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to such goods and services. For purpose of this Bid, ineligible countries are stated in the section-4 titled as “Eligible Countries”.</p> <p>4.2. For purposes of this Clause, “origin” means the place where the goods are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be supplied.</p> <p>4.3. The nationality of the supplier that supplies and install the goods shall not determine the origin of the goods.</p> <p>4.4. To establish the eligibility of the Goods and the related services, Bidders shall fill the country of origin declarations included in the Form of Bid.</p>



	4.5. If so required in the BDS , the Bidder shall demonstrate that it has been duly authorized by the manufacturer of the goods to deliver in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the goods indicated in its Bid.
5. One Bid per Bidder	<p>5.1. A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.</p> <p>5.2. No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.</p> <p>5.3. A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.</p>
6. Cost of Bidding	6.1. The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Procuring Agency shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
<u>B. Bidding Documents</u>	
7. Contents of Bidding Documents	<p>7.1. The goods required, bidding procedures, and terms and conditions of the contract are prescribed in the Bidding Documents. In addition to the Invitation to Bids, the Bidding Documents which should be read in conjunction with any addenda issued in accordance with ITB 9.2 include:</p> <p style="padding-left: 40px;">Section I -Invitation to Bids Section II Instructions to Bidders (ITBs) Section III Bid Data Sheet (BDS) Section IV Eligible Countries Section V Schedule of Requirements and Technical Specifications Section VI Standard Forms Section VII General Conditions of Contract (GCC) Section VIII Special Conditions of Contract (SCC) Section IX Contract Forms</p> <p>7.2. The number of copies to be completed and returned with the Bid is specified in the BDS.</p> <p>7.3. The Procuring Agency is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the Procuring Agency or the signed pdf version from downloaded from the website of the Procuring Agency. However, Procuring Agency shall place both the pdf and same editable version to facilitate the bidder for filling the forms.</p>



	7.4. The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will be at the Bidder's risk and may result in the rejection of his Bid.
8. Clarification of Bidding Documents	<p>8.1. A prospective Bidder requiring any clarification of the Bidding Documents may notify the Procuring Agency in writing or in electronic form that provides record of the content of communication at the Procuring Agency's address indicated in the BDS.</p> <p>8.2. The Procuring Agency will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in ITB 23.1. However, this clause shall not apply in case of alternate methods of Procurement.</p> <p>8.3. Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source.</p> <p>In case of downloading of the Bidding Documents from the website of PA, the response of all such queries will also be available on the same link available at the website.</p> <p>8.4. Should the Procuring Agency deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB 9.</p> <p>8.5. If indicated in the BDS, the Bidder's designated representative is invited at the Bidder's cost to attend a pre-Bid meeting at the place, date and time mentioned in the BDS. During this pre-Bid meeting, prospective Bidders may request clarification of the schedule of requirement, the Evaluation Criteria or any other aspects of the Bidding Documents.</p> <p>8.6. Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Bidders who have obtained the Bidding Documents. Any modification to the Bidding Documents that may become necessary as a result of the pre-Bid meeting shall be made by the Procuring Agency exclusively through the use of an Addendum pursuant to ITB 9. Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.</p>
9. Amendment of Bidding Documents	9.1. Before the deadline for submission of Bids, the Procuring Agency for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder or pre-bid meeting may modify the Bidding Documents by issuing addenda.



	<p>9.2. Any addendum issued including the notice of any extension of the deadline shall be part of the Bidding Documents pursuant to ITB 7.1 and shall be communicated in writing or in any identified electronic form that provide record of the content of communication to all the bidders who have obtained the Bidding Documents from the Procuring Agency. The Procuring Agency shall promptly publish the Addendum at the Procuring Agency's web page identified in the BDS: Provided that the bidder who had either already submitted their bid or handed over the bid to the courier prior to the issuance of any such addendum shall have the right to withdraw his already filed bid and submit the revised bid prior to the original or extended bid submission deadline.</p> <p>9.3. To give prospective Bidders reasonable time in which to take an addendum/corrigendum into account in preparing their Bids, the Procuring Agency may, at its discretion, extend the deadline for the submission of Bids: Provided that the Procuring Agency shall extend the deadline for submission of Bid, if such an addendum is issued within last three (03) days of the Bid submission deadline.</p>

<p>10. Language of Bid</p>	<p>10.1. The Bid prepared by the Bidder, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Procuring Agency shall be written in the English language unless otherwise specified in the BDS. Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant pages in the English language unless specified in the BDS, in which case, for purposes of interpretation of the Bidder, the translation shall govern.</p>
<p>11. Documents and Sample(s) Constituting the Bid</p>	<p>11.1. The Bid prepared by the Bidder shall constitute the following components: -</p> <ol style="list-style-type: none"> a) Form of Bid and Bid Prices completed in accordance with ITB 14 and 15; b) Details of the Sample(s) where applicable and requested in the BDS. c) Documentary evidence established in accordance with ITB 13 that the Bidder is eligible and/or qualified for the subject bidding process; d) Documentary evidence established in accordance with ITB 13.3(a) that the Bidder has been authorized by the manufacturer to deliver the goods into Pakistan, where required and where the supplier is not the manufacturer of those goods; e) Documentary evidence established in accordance with ITB 12 that the goods and related services to be supplied by the Bidder are eligible goods and services, and conform to the Bidding Documents;



	<p>f) Bid security or Bid Securing Declaration furnished in accordance with ITB 18;</p> <p>g) Duly Notarized Power of Attorney authorizing the signatory of the Bidder to submit the bid; and</p> <p>h) Any other document required in the BDS</p> <p>11.2. Where a sample(s) is required by a procuring agency, the sample shall be:</p> <p>(a) submitted as part of the bid, in the quantities, dimensions and other details requested in the BDS;</p> <p>(b) carriage paid;</p> <p>(c) received on, or before, the closing time and date for the submission of bids; and</p> <p>(d) evaluated to determine compliance with all characteristics listed in the BDS.</p> <p>11.3. The Procuring Agency shall retain the sample(s) of the successful Bidder. - 18.7. Unsuccessful Bidders' Bid Security will be discharged or returned as promptly as possible, however in no case later than thirty (30) days after the expiration of the period of Bid Validity prescribed by the Procuring Agency pursuant to ITB 17. The Procuring Agency shall make no claim to the amount of the Bid Security, and shall promptly return the Bid Security document, after whichever of the following that occurs earliest:
- (a) the expiry of the Bid Security;
 - (b) the entry into force of a procurement contract and the provision of a performance security (or guarantee), for the performance of the contract if such a security (or guarantee), is required by the Biding documents;

E. Opening and Evaluation of Bids

26. Opening of Bids

26.1. The Procuring Agency will open all Bids, in public, in the presence of Bidders' or their representatives who choose to attend, and other parties with a legitimate interest in the Bid proceedings at the place, on the date and at the time, specified in the BDS. The Bidders' representatives present shall sign a register as proof of their attendance.

26.2. First, envelopes marked "WITHDRAWAL" shall be opened and read out and the envelope with the corresponding bid shall not be opened, but returned to the Bidder. No bid withdrawal shall be permitted unless the corresponding Withdrawal Notice contains a valid authorization to request the withdrawal and is read out at bid opening.

26.3. Second, outer envelopes marked "SUBSTITUTION" shall be opened. The inner envelopes containing the Substitution Bid shall be exchanged for the corresponding Original Bid being substituted, which is to be returned to the Bidder unopened. No envelope shall be substituted unless the corresponding Substitution Notice contains a valid authorization to request the substitution and is read out and recorded at bid opening.

26.4. Next, outer envelopes marked "MODIFICATION" shall be opened. No Technical Proposal and/or Financial Proposal shall be modified unless the corresponding Modification Notice contains a valid authorization to request the modification and is read out and recorded at the opening of the Bids. Any Modification shall be read out along with the Original Bid except in case of Single Stage Two Envelope Procedure where only the Technical Proposal, both Original as well as Modification, are to be opened, read out, and recorded at the opening. Financial Proposal, both Original and Modification, will remain unopened till the prescribed financial bid opening date.

26.5. Other envelopes holding the Bids shall be opened one at a time, in case of Single Stage One Envelope Procedure, the Bidders names, the Bid prices, the total amount of each Bid and of any alternative Bid (if alternatives have been requested or permitted), any discounts, the presence or absence of Bid Security, Bid Securing Declaration and such other details as the Procuring Agency may consider appropriate, will be announced by the Procurement Evaluation Committee.

26.6. In case of Single Stage Two Envelope Procedure, the Procuring Agency will open the Technical Proposals in public at the address, date and time specified in the **BDS** in the presence of Bidders' designated representatives who choose to attend and other parties with a legitimate interest in the Bid proceedings. The Financial Proposals will remain unopened and will be held in



	<p>custody of the Procuring Agency until the specified time of their opening.</p> <p>26.7. The envelopes holding the Technical Proposals shall be opened one at a time, and the following read out and recorded: (a) the name of the Bidder; (b) whether there is a modification or substitution; (c) the presence of a Bid Security, if required; and (d) Any other details as the Procuring Agency may consider appropriate.</p> <p>26.8. Bids not opened and not read out at the Bid opening shall not be considered further for evaluation, irrespective of the circumstances. In particular, any discount offered by a Bidder which is not read out at Bid opening shall not be considered further.</p> <p>26.9. Bidders are advised to send in a representative with the knowledge of the content of the Bid who shall verify the information read out from the submitted documents. Failure to send a representative or to point out any un-read information by the sent Bidder's representative shall indemnify the Procuring Agency against any claim or failure to read out the correct information contained in the Bidder's Bid.</p> <p>26.10. The omission of a Bidder's signature on the record shall not invalidate the contents and affect the record. A copy of the record shall be distributed to all the Bidders.</p> <p>26.13. A copy of the minutes of the Bid opening shall be furnished to individual Bidders upon request.</p> <p>26.14. In case of Single Stage Two Envelop Bidding Procedure, after the evaluation and approval of technical proposal the procuring agency, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidder's subject to redress of the grievances from all tiers of grievances.</p>

Explanation: A minor informality, non-conformity or irregularity is one that is merely a matter of form and not of substance. It also pertains to some immaterial defect in a Bid or variation of a bid from the exact requirements of the invitation that can be corrected or waived without being prejudicial to other bidders. The defect or variation is immaterial when the effect on quantity, quality, or delivery is negligible when contrasted with the total cost or scope of the supplies or services being acquired. 1.0.11. All solutions loading/unloading processes into main and auxiliary tanks should pass through a system integrated filtration unit that must be capable of removing suspended particles and impurities from solution before starting electrolysis process.
1.0.12. The tank must feature a temperature control unit designed to regulate the temperature of the electrolyte solutions in the bath in accordance with the requirements for plate growth.
1.0.13. The thermoregulation float system unit/coil in main tank must be chemically resistant (particularly to 100% concentrated nickel sulfamate, sulfamic acid, boric acid, nickel chloride, sodium lauryl sulphate and nickel carbonate) and capable of withstanding temperatures up to at least 100°C.
1.0.14. The coil should be positioned in the bath in a manner that does not interfere with the electroplating or handling of the plates.
1.0.15. The thermoregulation coil must connect to the inlet and outlet of an automatic temperature control unit in a closed circuit to maintain the required electrolyte temperature for electroplating in a uniform manner.
1.0.16. A motorized and control-based system should be provided for loading, unloading, and adjusting the position of the plates within the bath.
1.0.17. All nickel bath environmentally exposed material must be chemical resist especially to hydrochloric acid HCL, nickel sulfamate, sulfamic acid, boric acid, nickel chloride, sodium lauryl sulphate and nickel carbonate, sulfuric fumes.
1.0.18. The tank must comprise holding frames for mounting plates matrix whose upper frame should be made of stainless steel that ensures perfect resistivity against any chemical reaction and corrosion.
1.0.19. Adequate number of Anode and Cathode bars to be provided with main tank for connection to rectifier and other auxiliary units of machine for plates growing process. The bars must be 100% chemical, abrasion, and temperature resistant on and off electrolysis process.
1.0.20. The anode and cathode bars must offer minimum resistant to current flow, enhancing electrical efficiency while performing the electrolysis process.



1.0.21. Nickel holding baskets (12 Nos.) made of titanium should be provided with main tank to be used in electrolysis/plates growing process
1.1 Tank Capacity/Electroplating Capacity
1.1.1. The tank must be designed with optimal dimensions and volumetric capacity to accommodate the plate growth process, adhering to the following specifications:
1.1.2. Number of Plates Holding Capacity: at-least 02 plates and capability to grow two plates simultaneously. However, if supplier's system bear growing capacity of more than 02 plates, accordingly additional cost incurred (cost breakdown) should be provided for the plates beyond 02 No. for our analysis. It will at sole discretion of procuring agency to go for 02 or more plates capacity.
1.1.3. Plate Dimensions: Length x Width x Thickness: (1080 x 945 x 1.500) millimeters (Tolerance: ±10%).
1.1.4. Weight of Single Plate: 12 kilograms (Tolerance: +100%).
1.1.5. Maximum time required for nickel electroplating in single go (02 or more Plates growing) should not exceed 18 Hours in any case. The plates growing process time should be adjustable to even lesser than 18 Hours, details of which are already composed in last paras of "Brief Description" above.
1.1.6. Bids that include auto-regulation of current, temperature, agitation and electroplating based on plate thickness requirements in the shortest possible time (<18 Hrs./at-least 02 Plates) will be prioritized.
1.1.7. Additional points will be awarded for the system that allow users to input desired thickness and allowable time, enabling automatic adjustments of current, temperature, and other process variables to complete tasks within specified timeframes.
1.2 THERMOREGULATION UNIT
1.2.1. The electroplating nickel bath should be equipped with a closed-loop thermoregulation unit housed in a sound proof canopy.
1.2.2. This system must be capable of maintaining the required temperature throughout the electroplating/growth process by controlling key control parameters including upper and lower temperature limits, flow rate, and pressure.
1.2.3. It must include an integrated, centrally monitored filtration system with inline flow regulation and filtration controls.
1.2.4. The thermoregulation unit must be robust enough to function effectively under the extreme temperature conditions of the electrolysis process, ensuring that electroplating process is not impeded or quality compromised, and that no defective plates production, chemical waste, material loss, or safety and environmental hazards occur.
1.2.5. The system should automatically adjust functioning of pumps, heat exchangers, control valves and other components to match the actual and required temperatures, maintaining optimal performance.
1.2.6. The system should feature a wide range of automatic processes and intelligent electronic controls, including a touch-screen HMI (Human-Machine Interface) for user interaction.
1.2.7. The user interface must display real-time data of thermoregulation system, alarms, and current operating conditions including pressure, flow rates, and temperature, with options for manual adjustments as needed.
1.2.8. It should also include a visual and/or audible error indication system (such as a buzzer) to alert the operator of any anomalies or deviations from the required parameters.



1.2.9. In case, parameters exceed predefined safety thresholds, the system should have a built-in safety mechanism to stop the process with display of fault, reason and remedial action.
1.2.10. The core heat exchange mechanism should use copper-made cooling coils for maximum efficiency in heat exchange, minimizing energy loss.
1.2.12. The bidder must provide detailed technical specifications for the built-in heat exchanger and expansion valve system. The thermoregulation system should include:
1.2.12.1. All circulation pumps of thermoregulation unit must be at-least IP54, Single/Three Phase, 220V/400V±10%;
1.2.12.2. Pump compliant to ISO-9900-Series, and pump-motor to IEC class 6000 or their Equivalent
1.2.12.3. Operating Frequency 50Hz±1%;
1.2.13. A system for quick-connect connection to pre-installed chilled water supply system
1.2.14. 100% efficiency electrical heaters and must follow latest version of IEC Class 6000 Series or equivalent
1.2.15. Thermostat efficiently working within safe range of operating condition of unit with calibration and testing standard/certificate.
1.2.16. Complete thermoregulation system be equipped with mechanical pressure safety & relief valves, electronic controlled pressure and flow regulation valves, electronic pressure & temperature gauges and other accessories necessary for trouble-free operation & monitoring of unit.
1.2.17. The thermoregulation coil in direct contact with bath tub or exposed to environment must be resistant to liquid and gaseous chemicals especially to the ones mentioned above.
1.3 MEASUREMENT & INSTRUMENTATION
1.3.1. The complete nickel coating tub alongside its ancillary units (including thermoregulation, steel tank, rectifier, filtration unit) must be equipped with electronics control based measuring gauges and probes as per compliance to relevant IEC 6000 series standards or their equivalent.
1.3.2. All these equipment and controls to be installed over different units of machine and displayed on main/auxiliary consoles. Furthermore, hardness and roughness tester should be required for dp plate testing.
1.3.3. The parameters needed to measure and monitor include temperatures, pressures, flow-rates, pH, growing rate, time lapsed and remaining time for completion of growing/electroplating process. Additional score will be awarded to one offering the option of real-time tracking, monitoring and recommendations as per current composition of the chemical being used in ongoing electrolysis process.
1.3.4. All probes and control circuitry must be calibrated and tested as per relevant international standards and connected via feedback system to main control console of bath tub and/or thermoregulation indicating live condition and potential abnormalities/errors and their remedial actions.
1.3.5. Measuring probes should be positioned in bath tub, filtration system, thermoregulation unit and other ancillary units and auto-actuated control circuit whenever respective parameters goes out of pre-defined/standard values.
1.3.6. Stainless steel footbridges need to be fitted on two longitudinal sides of the working tank for operator ease and handling works.



1.4. RECTIFIER SYSTEM
1.4.1. The complete nickel electroplating process to be powered and energized by a micro-processor-based rectifier system developed to work smoothly in nickel-based chemicals as mentioned above with inline filtration, thermoregulation and agitation system.
1.4.2. The rectifier will support and control electroplating/plates growing process through sets of cathode and anode type electrodes connected through copper bus bars. The rectifier to be equipped with necessary transformers, switches, breakers, and measuring digital gauges for voltage, current, power and other relevant electrical parameters.
1.4.3. All electrical/electronic components including cables must comply to relevant clauses of IEC-6000 Series or their equivalent.
1.4.4. The bidder must explicitly mention the standard followed for designing, functioning and performance of components installed in rectifier.
1.4.5. The rectifier must be protected by proper earthing, temperature, voltage, current and frequency surge protections, short circuits, overloads and other securities for safe, smooth and reliable functioning of rectifier unit and the operator.
1.5 ENVIRONMENT PROTECTION AND STANDARDS COMPLAINE
1.5.1. The complete electroplating process must be as per international environment protection agency's obligations and international labor protection laws.
1.5.2. The machine must have a well-defined mechanism for handling/extracting gaseous components/fumes produced during the electrolysis process as a result of chemical reactions.
1.5.3. The bidder must explicitly specify with details the defined mechanism for handling of the effluents produced in electroplating process as waste/by-product. A separate option of effluent treatment system to be offered with complete technical and operational details. However, its acquisition is at sole discretion of procuring agency.
1.5.4. The system must be robust enough to capture at-least 95-100% of fumes without allowing them to enter surrounding environment, posing safety hazard to operator and environment. A mechanism for treating the captured fumes/impurities to be elaborated in technical bid and its durability, level of efficiency.
1.5.5. A real-time monitoring probe/sensing mechanism be provided with electroplating system measuring the level of environmental pollutants and pH of air, during the chemical reactions and its indication on main console.
1.5.6. Buzzer/Indication over main console in case air pollutants exceeds pre-defined safety level. In this regard, the system must be capable enough to maintain safe environmental operating conditions following the aforementioned production requirements. The gaseous components/particulate matters produced must be handled by the pre-installed fumes capturing system.
1.5.7. It is highly desirable that very minimum maintenance and operational cost be incurred on this feature of fumes and air particulate matters capturing system. In this regard, the cost of operations/consumables, maintenance, and spares must be explicitly quoted in financial bid.
1.5.8. The system must have the capability of full compatibility and retrofitted to a pre-installed effluent treatment plant at PSPC and their mechanical, electronics and control be integrated efficiently and cost-effectively. In this regard, feasibility details of retrofit be provided in technical bid.



1.5.9. The by-product produced after chemical reaction/electrolysis process should be manageable for transferring through a well-defined pumping system to a reserve tank or to effluent treatment plant for further process, all through the main/auxiliary control console.

1.6 GENERAL REQUIREMENTS

1.6.1. The complete delivery of supplies and services including but not limited to supply, installation, commissioning and training of nickel electroplating machine must be done in less than 12 months (or as mutually agreed) from Issuance of LC to the supplier. Additionally, it is recommended that the potential vendors perform a pre-bid meeting with procuring agency for any clarification from both ends, necessary discussions before submission of bids (if needed). The meeting may be physical or virtual, as deemed appropriate and agreed by both parties. Pre-bid meeting to follow aforementioned clauses 8.5 and 8.6.

1.6.2. The machine must have a minimum production/growing capacity of 02 plates per 18 Hours with continuous operation round the clock considering 03 x shifts per day (each shift of 08-hours). The electroplating machine must be fully compatible with post-nickel growing PVD based and/or Electrolysis Solution Based Chrome Plating processes without compromising surface thickness, roughness and strength while ensuring generation of not more than 1% process waste either of in the form of faulty plates, environmental hazard, consumables usage or power and thermoregulation over usage.

1.6.3. The bidder should provide detailed information, activity breakups and performance data in their offer to demonstrate the machine's ability to meet this production requirement effectively, accounting for the necessary cleaning and maintenance activities.

1.6.4. PSPC requires that the complete setup be fully compatible with the existing infrastructure and utilities of PSPC. To ensure this, the bidder may conduct a site visit to gather data and assess all necessary requirements on bidder's expenses.

1.6.5. It is important to note that any additional requests or modifications from the successful bidder after contract award will not be considered. The bidder is responsible for supplying a machine, along with all necessary equipment including pre-&-post electroplating setup (if required), to meet the printing plates making requirements as outlined in their bid.

1.6.6. Any additional components or specifications identified later that are necessary for trouble-free and smooth printing but not included in the submitted bid will be provided entirely at the bidder's expense.

1.6.7. All exposed parts and components shall have protective coating to resist corrosion, erosion, and pitting when in contact with chemicals during standard operation and cleaning.

1.6.8. The bidder must ensure availability of after sale support (Spares and Services) of 10 years for electrical/electronic, control/programming and 12 years for mechanical and must be provided on a separate letter of company.

1.6.9. The bidder must offer at-least 10 Years warranty of bath tub against leakage and abrasion, electrodes against corrosion/performance degradation by not more than 05%, rectifier against current leakage and relevant safeties, provided on company letter head.

1.6.10. OEM shall provide two years trouble free operational warranty of complete setup with back up support including 02 health check visits entirely at the bidder's expenses. The warranty shall cover all expenses pertaining to spares, repairs, adjustments, and replacement works of any part that has worn out or damaged during this period due to any reason.

1.6.11. Complete setup and auxiliaries must be accompanied by all relevant software, modules, PLCs, controls, safeties, consoles, auxiliaries, maintenance and data management systems.



1.6.12. The system shall contain a watch dog which would stop the complete process if there is an error with the system Software/Hardware and shall have the data logging facility for at least 30 days.
1.6.13. The history of errors and activity encountered by the system shall be logged for at least 60 days.
1.6.14. The vendor must ensure the trouble-free continuous operation of machine during the warranty period. Vendor shall be responsible to arrange the spare part(s) at his own cost immediately (or within 05 days in case of foreign import) during the warranty period.
1.6.15. Complete set of recommended/critical machine parts to facilitate two-year trouble-free operation on continuous 24/7 basis. However, the list of consumables along with detail (including consumption pattern) must be provided in the bid. This shall be provided as a sperate breakdown in the bid for the purchaser to make a better buying decision.
1.6.16. Provision of all machine programs/software with complete backup images and updated electrical and mechanical drawing in hard and soft form.
1.6.17. Technical training of at-least 02 number of persons for complete electroplating process and 02 number of person for maintenance (electronics/electrical and mechanical) to ensure best operational practices and troubleshooting issues of the machine at manufacturer site as well as at PSPC premises after installation. The entire cost of travelling, lodging and boarding of PSPC team shall be borne by PSPC. However, the cost of training shall be borne by the supplier.
1.6.18. On-site installation, testing and commissioning and putting into operation complete setup with all its related systems. After installation of bath tub and auxiliaries at PSPC premises, the supplier shall provide onsite hands-on training to PSPC operation and maintenance teams. The entire cost of travelling, lodging and boarding of the trainer(s) shall be borne by the supplier.
1.6.19. In case of any uncertain damage of installed parts, the provision of respective part on FOC basis must be ensured by the bidder under the warranty period claim.
1.6.20. Spares and Service support from OEM for complete electronics should be available for next 10 years and mechanical for next 12 years. Accordingly, service support for all computer hardware and software's should be provided for next 10 years.
1.6.21. Standalone Supporting Equipment should be provided separately (for example Vacuum Pump/Air Compressor, HVAC related Auxiliaries, Electric Cabinet of the line, Switch Gear Cabinet, Power Supply and Control Cabinet, Thermoregulation Units, Expert Workstation and so forth).
1.6.22. All accessories required for operation and maintenance of the system shall be provided along with Machine. Tools kit, One Service PC/Laptop/Test units for PLC programming (if any), fault finding, loading, editing, and correction shall be provided along with the machine.
1.6.23. The levels of noise (if any) shall not exceed safe audible range, preferably 84 dBA according to EN 13023 at the main working areas of the system, at times of full output.
1.6.24. Contactless sensors should be installed on the doors and covers and stop machine when a door/cover is opened.
1.6.25. Plates storage support containers should be provided with setup for handling and storing prepared plates. They should have the capacity to handle 12X plates at a time. Prices should be quoted separately; however, procurement of these containers will be at sole discretion of procuring agency.



1.6.26. The history of errors and activity encountered by the system shall be logged for at least 30 days and shall be transferable to extended devices like hard drive, USB etc.

1.6.27. The general requirements mentioned above are indicative and in case of any superior system are offered which meet the actual operational and functional requirement, same will be considered.

1.6.28. PSPC mandates that the complete nickel electroplating setup must be entirely compatible with the existing chrome plating setup and must comply to PSPC future needs of adopting PVD technology for chrome plating process.

1.6.29. Any additional requests or modifications from the successful bidder after the award of contract will not be accommodated.

1.6.30. The bidder is responsible for supplying the complete system along with equipment necessary to meet the electroplating requirements as incorporated in bid subsequently verified/validated by PSPC.

1.6.31. 02 sets of operation, maintenance and vendor manuals including spares catalogue, electrical drawings, mechanical assembly/parametric drawing and other relevant drawings for the machine and all auxiliary equipment must be provided. The manuals should include generic specifications of all mechanical and electrical/electronic spares used over the system.

1.6.32. Detailed maintenance manuals must include system assembly and sub-assembly drawings, featuring exploded views of mechanical assemblies.

1.6.33. The bidder must provide complete technical details and recipes of chemicals & solutions required for plates growing process. The recipe should accompany all details including but not limited to quantity/ratio of components, pH value, temperature, other chemical and physical properties required to be maintained.

1.6.34. Any additional key part, equipment, system or setup mandatory for this process will be arranged, supplied and commissioned/installed by contractor solely at their own expenses.

1.7. INTERNATIONAL STANDARDS

1.7.1. ASME-BPVC based certification & ASME-BPVC PRD for pressure relief valves used in thermoregulation unit.

1.7.2. ASTM / ISO based Tensile, Yield, impact and Strain Testing certificates for Metallurgy/Material of main and auxiliary tanks.

1.7.3. IEC 60204 and relevant series safety of machinery – Electrical equipment of machines or their equivalent.

1.7.4. IEC 60038 and relevant series IEC Standard Voltages or their equivalent.

1.7.5. IEC 60059 and relevant series standard current ratings or their equivalent.

1.7.6. Or any other international standard if applicable.

1.8. FACTORY ACCEPTANCE TEST (FAT)

In addition to the standard FAT protocol of supplier, following points shall also be demonstrated by the supplier without any fail:

1.8.1. Verification of all sensors and actuators during production and in idle condition of machine

1.8.2. Electrical and electronic components, including wiring, sensors, and communication modules, must be tested to ensure correct installation and functionality. Software and firmware should be verified for correct installation and updates, with software functionalities including configuration, monitoring, and diagnostics features tested.



1.8.3. The manufacturer of Nickel Bath will perform plate growing process over same type of system at their site and send to PSPC for trial run over our printing machines for performance assessment. The plate may have any design as per PSPC alto/master plates design parameters.
1.8.4. Other Auxiliary Equipment operations and compatibility with machine must be ensured during the both trials and in idle condition of machine.
1.8.5. Supplier shall be responsible to ensure the required environmental parameters during FAT production trial.
1.8.6. Supplier shall demonstrate the practical compliance and functionality of all the specifications outlines in BOQ (whichever asked by the PSPC team)
1.8.7. Any issues or deficiencies found during the FAT should be documented and resolved along with demonstration to PSPC team, prior to shipment. Formal sign-off from relevant stakeholders, including technical representatives and project managers, is required to confirm that the machine has passed the FAT and is ready for shipment.
1.8.8 FAT will be conducted by PSPC team comprised of 02 x members. The cost of their travelling, lodging and boarding shall be borne by PSPC.
1.9. SITE ACCEPTANCE TEST (SAT)
1.9.1. Verification of all safeties, sensors and actuators during production and in idle condition of machine
1.9.2. Electrical and electronic components, including wiring, sensors, and communication modules, must be tested to ensure correct installation and functionality. Software and firmware should be verified for correct installation and updates, with software functionalities including configuration, monitoring, and diagnostics features tested.
1.9.3. A trial run of electroplating process with all auxiliaries operational, to ensure the smooth electroplating/plate growing process without any stoppage or anomaly. The test must comply to all of our technical specifications including accuracy, efficiency and production capacity of plates.
1.9.4. The aforementioned production run must be done on actual product range of PSPC (i.e. Rs.20/-, Rs. 50/-, Rs. 100/-, Rs. 500/-, Rs. 1000/- & Rs.5000/-). 02 Plates of each or random denominations will be tested for confirmation of technical viability.
1.9.5. Other Auxiliary Equipment operations and compatibility with machine must be ensured during both: the trials and in the idle condition of machine.
1.9.6. All acceptance criteria specified in the tender document must be met, with any deviations or issues identified during testing addressed and resolved before final acceptance. Any issues or deficiencies found during the SAT should be documented and resolved by the bidder prior to approval of SAT and issuance of commissioning certificate from the procuring agency.
1.9.7. On-site installation, testing and commissioning and putting into operation complete machine with all its related systems.

**TECHNICAL EVALUATION CRITERIA:**

All aforementioned items/specification must be complied by the bidder for minimum qualification.

After qualifying on above items, following additional scoring criteria will be followed:

CODE OF CONDUCT

Objective

This Code of Conduct aims to establish PSPC's business and employment practices on the highest standards of ethical behavior, integrity, accountability, courage and excellence.

It also aims to ensure that all concerned adhere to PSPC's defined core values, act with prudence, protect the interests of PSPC and maintain a positive work environment.

Scope

This Code of Conduct is applicable on all PSPC Employees, Contract Employees, Trainees, Apprentices, Deputationist, Outsourced Workforce, and other stakeholders.

General Behavior

The ethical principles of the Corporation prevail over the concerned individual's personal origins, beliefs, values, opinions, preferences, or habits at all times. All concerned, while they are in PSPC's service, shall strictly adhere to the following rules of General Behavior at all times which include, but are not limited to, the following responsibilities:

- 3.1. Comply with all applicable laws, including, but not limited to, those pertaining to general employment, anti-fraud, corruption, bribery, anti-discrimination, anti-harassment, health, safety and environmental protection.
- 3.2. Conduct themselves honestly and carry out their duties diligently and impartially to the best of their abilities, in compliance with the applicable rules, regulations, policies and procedures, as defined by PSPC from time to time.
- 3.3. Maintain highest standards of ethics and professionalism and devote their working activities to the service of PSPC.
- 3.4. Not guarantee or promise employment of any type to anyone for any length of time.
- 3.5. Assist and advise colleagues and show openness and transparency in all dealings with them.
- 3.6. Do not withhold information from concerned colleagues that may affect the conduct of business, particularly in order to gain a personal advantage. Providing false, inaccurate or exaggerated information, refusing to cooperate with colleagues or demonstrating any form of obstructive behavior is strictly not allowed.



3.7. Not indulge in any activity during off duty hours that directly or indirectly undermines the provisions of this Code, other PSPC rules, policies and procedures, or brings disrepute to PSPC.

3.8. Refrain from indulging in any illegal and unlawful activity including but not restricted to substance abuse and consumption of alcohol, drugs or any kind of intoxicant(s), as well as, any sort of gambling/betting activities, etc.

3.9. Officers of PSPC performing supervisory functions/roles on behalf of PSPC shall take every possible care to act within the delegated authority as provided by any law, rules or regulations under which such officers may purport to act.

Fraud, Embezzlement & Misrepresentation

4.1. All concerned shall not commit, or assist any activity that involves making false statements, fraud, forgery, misappropriation, theft, embezzlement, bribery, misrepresentation, violation of PSPC rules and regulations, policies and procedures or any similar activity that harms, or may harm the interest and reputation of PSPC.

4.2. Be honest in conveying professional conclusions, opinions, research and findings for whatever purpose and shall not manipulate the system for personal gains.

4.3. Refrain from indulging in any illegal and unlawful activity.

4.4. Abstain from any false or intentionally misleading information and declarations, bogus documents, and submit false or misleading claims with wrong information.

Discrimination and Harassment

5.1. All concerned shall treat all internal and external stakeholders with respect, fairness and courtesy and avoid all such forms of behavior that create or may create an atmosphere of harassment, hostility, intimidation and discrimination of any kind, especially involving age, gender, health, ancestry, physical disability, race, religion, length of service, political beliefs, marital status or family structure.

5.2. Shall not propagate in any manner whatsoever sectarianism, ethnic / regional hatred / animosity and take part in sectarian, ethnic, linguistic or parochial activities, as well as partiality or favoritism on these bases, indulge in nepotism, victimization, willful abuse of power, and unwarranted negative criticism and gossip about other employees.

5.3. Avoid creating / sending / forwarding electronic or any other form of communication that contains statements or material, which is discriminatory, offensive, defamatory, illegal or constituting harassment.

5.4. Refrain from engaging in any form of inappropriate relationship with persons with whom they have a professional relationship.



Confidentiality

6.1. All concerned shall maintain strict confidentiality of PSPC and its constituents affairs and shall not communicate directly or indirectly to their colleague(s) or (ex) employee(s) belonging to other department(s) or profession or to the press or public, any document or information which has come into their possession in the course of their official duties, or has been prepared or collected by them in the course of their duties, whether from official sources or otherwise, unless compelled to do so by judicial or other authority or unless instructed to do so by a superior officer in the discharge of his / her duties.

This confidentiality must be maintained by the employee even after the cessation of their employment with PSPC.

6.2. All concerned shall not give any evidence, document, or any information before a public committee without the prior approval of the Competent Authority.

6.3. Interaction or communication directly or indirectly on behalf of PSPC with foreign governments, media, and missions in Pakistan without seeking clearance from the competent authority is not permissible.

Use of PSPC Assets and Resources

7.1. All concerned are required to use PSPC assets such as properties, office equipment, supplies etc. for PSPC's business purposes and not for gain or benefit of persons or entities other than PSPC, including self.

7.2. Material information such as information contained in any file, document, note, report, letter, fax, USB, email, instrument, etc. held by the concerned must be used solely for the purpose of PSPC business and returned to PSPC upon cessation of employment / contract agreement.

7.3. Official information, documents, reports, proposals, research papers, software, etc. developed using PSPC time and resources constitute PSPC's intellectual property. All concerned will neither have the right to claim these as their own, nor shall they use/exploit the same for personal gain or benefit of persons or entities other than PSPC during or beyond cessation of their employment with PSPC.

Political Affiliation

8.1. No employee of PSPC shall take part in or subscribe in aid of or assist in any way, any political activity / movement in Pakistan or relating to the affairs of Pakistan, or take part in, or in any way assist, any movement or activity, which is, or tends directly or indirectly to be, subversive to Government as by law established in Pakistan or detrimental to the ideology or integrity of Pakistan.

8.2. Employees shall not canvass or otherwise interfere with or use their influence in connection with or take part in any election to a legislative body, whether in Pakistan or elsewhere, provided that an employee who is qualified to vote at such election may exercise



their right to vote; but if he/she does so, he/she shall give no indication of the manner in which he/she proposes to vote or has voted.

Attendance and Punctuality

- 9.1. All concerned shall not leave the office or absent himself / herself from duty, without prior permission of the Competent Authority.
- 9.2. Strictly adhere to defined break timings, as defined by PSPC from time to time.

Conflict of Interest

- 10.1. All concerned are required to recognize and disclose activities that might give rise to conflicts of interest or the perception of conflicts and to ensure that such conflicts are properly managed or avoided. All disclosure should be made at the time the conflict arises, or when it is recognized that a conflict may be perceived, in writing to the supervisor. If the supervisor also has an interest in the matter, the disclosure shall be made to the next higher level of authority.
- 10.2. While an officer is serving in PSPC, their spouse, children and siblings will henceforth not be eligible for recruitment in PSPC, SBP and/or any of its other subsidiaries.

Gifts and Entertainment

- 11.1. Except as permitted, employees shall neither receive nor give any gift(s) or favor(s), in cash or any kind, from / to any organization, including those stakeholders (individual, entities or person created by law) who are in contact with PSPC.
- 11.2. The above instructions will not be applicable in case;
- a. A gift received for value of up to Rs 10,000 provided aggregate value of gifts received / given from / to during a fiscal year from same source does not exceed Rs 20,000;
 - b. Advertising materials including trade discounts that an individual or entity normally offers to its general customers;
- 11.3. The intended recipient will politely refuse the offer of gifts valuing above. However, where such refusal may impact the official relationships, the gift so received would be immediately, but not later than 72 hours, surrendered to HR.

Prohibitions



12.1. Smoking or other use of tobacco products (including, but not limited to, cigarettes, pipes, cigars, electronic Cig, snuff, or chewing tobacco) is not permitted within the office premises. Employees may smoke outside in open air, at the designated areas, without compromising on the working hours.

12.2. Use of any sort of drug including Pan, Gutka, Naswar, etc. within the office premises is not allowed.

Self-Disclosure of Criminal Conviction

All employees are required to self-disclose any criminal offence for which any investigating agency have taken cognizance and for which a conviction has been decided against such an employee by any court of law while being professionally engaged with PSPC irrespective of the nature of engagement.

Health & Safety

All employees must take measures to promote safe working practices, and follow the instructions given by the Health, Safety, and Environment Team from time to time.

Whistleblowing

All concerned are responsible to immediately report any alleged ethical misconduct or fraud. The employees may raise their concerns through a written report or email at whistleblower@pspc.gov.pk. For more information on the applicability of this policy, refer to Whistleblowing Policy.

Compliance with the rules of conduct

Role of line managers

16.1.1. Line managers shall take the necessary measures to encourage respect for the rules of conduct within the entities for which they are responsible.

16.1.2. Managers should ensure that employees placed under their authority are aware of this code.

16.1.3. Apart from the vigilance, line managers are expected to behave in an exemplary manner as regards respect for the principles and rules set out in this code.

16.2. Any information pertaining to violation of this Code must immediately be reported to Director Human Resources.

16.3. If Director Human Resources is found to be violating this Code, MD may be reported. In case of violation by MD, Chairman PSPC may be reported.



Reporting Confidentially

17.1. All stakeholders when reporting to Director HR shall be deemed to have made such report in strict confidence.

17.2. Human Resource Department shall not disclose the identity of concerned employee to other parties unless it is in the interest of the Corporation or it is required by law.

Consequences of Violating the Code

18.1. Any employee who violates the Code shall be subject to disciplinary action.

18.2. Failure to report deviations of the Code by all concerned may result in disciplinary action. Similarly, failure to report deviations of the Code by other stakeholders may result in the termination of their relationship with the Corporation.

Interpretation

This policy shall supersede all previous policies on the subject. In case of any ambiguity in understanding this Policy, the interpretation of the Managing Director will be treated as final. Any exception to the policy shall be approved by the Managing Director on the recommendation of Director HR and shall be reported to Board Human Resource Committee for ratification.

(PSPC and _____ are hereinafter collectively referred to as the “Parties” and individually as a “Party”).

Agreement’ means this Agreement and all written amendments and revisions made thereto from time to time.

“Effective Date” means the date of execution of this Agreement.

‘State’ means the territory of the Islamic Republic of Pakistan.

WHEREAS

The Parties to this Agreement wishes to enter into an Agreement concerning the disclosure of certain proprietary and confidential information, whereby it will be necessary for each party (the "**Disclosing Party**") to disclose to the other Party (the "**Receiving Party**"), as the case may, information of a confidential or proprietary nature for the purposes as defined in the Agreement (**Authorized Purpose**) (irrespective of the form of presentation or communication including, but not limited to data, notes, analyses, compilations, studies, physical objects, samples, financial information, technical information, cost information, techniques, , material, methods, processes, sources and any



other information, however, described, which is or could be valuable in the type of business in which Disclosing Party is engaged) provided that any disclosure of information made in writing shall be marked confidential or with words of similar effect and that any disclosure made orally shall subsequently be reduced to writing by the Disclosing Party and marked confidential or with words of similar effect with a copy sent to the Receiving Party within 30 days of disclosure ("Information").

IT IS AGREED AS FOLLOWS:

1. This Agreement will apply to any disclosure of Information on the Effective Date. This Agreement may be terminated by any Party after giving a prior notice of 30 (Thirty) days' in writing; or immediately if the Disclosing Party has reason to believe that the Receiving Party is in breach of any of the obligations contained herein. Such termination shall not affect any obligation imposed by this Agreement with respect to Information received prior to such termination.
2. Receiving Party shall, forthwith upon receipt of a written request from the Disclosing Party or on termination:

- (i) return all information supplied by the Disclosing Party as well as items and materials relating to or derived from the Information;
 - (ii) deliver to the Disclosing Party or at its request destroy immediately all items and materials made by the Receiving Party containing Information, that are not returned pursuant to paragraph (i) above;
 - (iii) not keep copies or duplicates of any items or materials referred to in paragraphs (i) or (ii) above; and
 - (iv) provide a certificate signed by a senior officer of the Receiving Party confirming that the provisions of this clause have been complied with.
3. This Agreement shall not apply to any Information which the Receiving Party: (a) can show is or becomes publicly available through no fault of the Receiving Party; (b) can show was in its possession prior to the date of disclosure; (c) may subsequently receive from any third party legally in possession of the Information and who was not restricted from disclosing it; (d) can show is independently acquired by the Receiving Party as a result of work carried out by an employee, consultant or contractor of the Receiving Party to whom no disclosure of Information has been made; or (e) is required to disclose pursuant to a court order or any law/rules/regulations provided that the Receiving Party shall have given prior written notice to the Disclosing Party.
4. This Agreement shall not be deemed to confer or imply the grant or agreement to grant by the Disclosing Party to the Receiving Parties of any of its rights under copyright, patents, trademarks, design rights or other similar rights. All Information supplied hereunder is supplied on an "as is" basis and the Disclosing Party gives no representation or warranty as to its accuracy, completeness or fitness for any purpose other than the



Authorized Purpose. The Disclosing Party shall not be liable for any loss or damage suffered by the Receiving Parties as a result of any Receiving Party’s use of the Information.

- 5. This Agreement does not create any agency or partnership relationship and each party shall act as an independent entity. This Agreement will not be assignable or transferable by the Parties. All additions or modifications to this Agreement must be made in writing and signed by the Parties.
- 6. Notices shall be delivered personally, or by prepaid first class mail, or transmitted by facsimile to the Parties at such address or number as the parties shall specify from time to time.
- 7. The Receiving party may obtain consent of the Disclosing party for any waiver of rights, to share information received under this Agreement to a third party for the Authorized Purpose. Any waiver of any right under this Agreement is only effective if it is in writing and applies to the specific circumstance for which it has been given.
- 8. In the event of a breach, Disclosing Party shall be entitled, in addition to any other remedies and damages available at law or in equity, to an injunction to restrain the violation thereof by Receiving Party, or its employees, contractors, agents, representatives and consultants ,
- 9. This Agreement shall be governed by and shall be construed in accordance with the laws of Pakistan. In case a dispute arises between the Parties with regard to the terms of or rights and obligations of the Parties under this Agreement, if not resolved amicably, shall be referred to the arbitrator to be mutually appointed by the Parties. The arbitration shall be carried out in accordance with the Arbitration Act, 1940 in English. The award shall be conclusive, and binding on the Parties and the Parties submit to the non-exclusive jurisdiction of the Pakistan’s Courts.

 - h. the Supplier’s Letter of Acceptance
 - i. Integrity Pact
 - j. Performance Security (Guarantee) Form
 - k. Certificates to Contract
 - l. Undertaking for compliance with PSPC code of conduct

In consideration of the payments to be made by the Procuring Agency to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Agency to provide the goods and related services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Agency hereby covenants to pay the Supplier in consideration of the provision of the goods and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the contract.

- 18. TERMS OF SHIPMENT**
- a). The supplier shall arrange shipment / dispatch of material as per given schedule through PNSC’s own or vessels chartered by them or any other vessel authorized by buyer. The freight will be paid to PNSC / other shipping line in local currency.
- b). The supplier shall be responsible for making arrangement for the PNSC vessel. In case, consignment on C&F basis, the supplier shall make necessary arrangement for airline / courier service.
- c). No transshipment is allowed.
- d). Packing list, one outside & one inside the package, showing gross and net weight and measurements should accompany each shipment.
- e). The quantity to be dispatched / shipped shall not exceed the value of letter of credit / CAD contract.



19. SHIPPING ADVICE

Within 48 hours after completion of the loading / dispatching of goods, the "SUPPLIER" shall advise the "BUYER" by fax / e-mail the contract No., name of commodity, contracted month of delivery, quantity, gross & net weight and measurements, bill of lading / AWB, date of loading / dispatching and port of destination and he will arrange to send 02 sets of non-negotiable documents to **Dy General Manager Purchase PSPC, Karachi** Original shipping documents to bank if "BUYERS" incur demurrage on account of "SUPPLIER" failure in giving advice of shipment in time by fax / e-mail the delay in receiving non-negotiable documents or original documents to bank "SUPPLIER" shall be held liable for such demurrage.

20. MODE OF PAYMENT

Payment to supplier shall be made through irrevocable letter of credit and shall be negotiable on presentation of original shipping documents.

All bank charges in connection of L.C in Pakistan are borne by PSPC and all foreign bank charges to be borne by beneficiary. Any subsequent changes to the letter of credit will be charged to party at whose behest the amendment will be made.

The letter of credit shall be established with following additional conditions:

- i) Please send the documents by DHL along with certified copy of DHL consignment note number and also fax the consignment note number as well as the date separately.
- ii) Clean re-imburement not allowed and send the documents to bank, on receipt of documents free from any discrepancy, they will remit funds as per our instruction.

The documents to be negotiable against presentation of following:

- i) Three copies of "SUPPLIERS" invoice indicating Purchase Order No, and date, name of item, gross & net weight, shipping marks, lot No also indicate letter of credit number and open insurance policy number as stated in the letter of credit
- ii) Full set (3 negotiation copies) of clean on-board ocean bill of lading (B/L).
- iii) Two copies of packing list indicating number of packages and gross & net weight and measurements.
- iv) One duplicate copy of "SUPPLIERS" shipping advice.
- v) Two copies of certificate of weight & quantity issued by the manufactures / suppliers.
- vi) Two copies of certificate of origin issued by the Chamber of commerce and industry. The "SUPPLIERS" shall arrange to send 02 copies of invoice to General Manager (F&A) and 02 set of shipping documents to General Manager Purchase PSPC Karachi and one set of documents to National Insurance Company Ltd. NICL Building Abbasi Shaheed Road, Karachi Pakistan.
- vii) The original documents must be received by our bank before arrival of vessel. Demurrages due to delay in provision / presentation of original documents will be on account of supplier.

21. INSURANCE

The "BUYER" shall arrange marine insurance of the goods under their open policy # **NICL/M/SZ/OP/PSPC/3450/2022-23** with National Insurance Company Limited, NICL Building Abbasi Shaheed Road Karachi (Pakistan). However, the "SUPPLIER" shall make a declaration of the shipment of goods to the Insurance Company mentioned above, quoting reference of the open cover specified above.

22. LIQUIDATION

The "SUPPLIER" shall pay to the "BUYER" at the rate of 2% per month or part of month for the value of the stores which the "SUPPLIERS" have failed to deliver within the stipulated delivery period, provided that damages shall not exceed 10% of the total price payable under the purchase contract.

**23. FORCE MAJEURE**

The "SUPPLIER" shall not be held responsible for late or non-delivery of the goods due to strikes and generally recognized force majeure causes. However, in such cases, the "SUPPLIER" shall deliver to the "BUYER" a certificate of the accident issued by competent **Government** authorities and / or the Chamber of Commerce at the place where the accident occurs as evidence thereof.

24. INSPECTION

The "BUYER" or his authorized representative shall have the right to inspect any goods after or before the dispatch from the "SUPPLIER" factory or premise. However, such inspection shall not absolve the "SUPPLIER" from the responsibility or liability for the delivery of goods according to the contracted specification nor shall interpreted so as in any way to imply acceptance of such goods.

25. WARRANTY

The "SUPPLIER" shall provide a warranty that the supplies made by them are highest grade in quality consistent with the established and generally accepted standards. The "SUPPLIER" shall protect and indemnify the "BUYER" against loss, damages and expenses what ever that the "BUYER" may suffer as a result of failure of the material to render useful service and that this warranty to remain to effective after inspection & payment as to the patent or latent defects detected after in installation or in the course of installation.

26. CLAIM

If the "SUPPLIER" fail to deliver the goods within the period stipulated in the contract, or if the goods are short in weight, or if the packing of goods is not in conformity with the contracted specification or reference samples, or if the goods are otherwise not in accordance with the contracted specification the "BUYER" shall have the right, in addition to and not withstanding their rights to claim compensation for breach of contract, to terminate the un-expected part of the contract and make purchase from other sources at the risk and cost of "SUPPLIER". The "SUPPLIER" shall settle all claims preferred by the "BUYER" within 15days of the receipt of the same and in the event of their failure to do so shall be liable to pay interest at 14% per annum on the amount claimed.

27. PERFORMANCE GUARANTEE

Within 15 days of signing of this contract the "SUPPLIER" shall furnish a performance guarantee either in the form of Demand Draft or a Bank Guarantee for 05% of the value of this contract. The Performance guarantee will be retained by the BUYER till receipt of material / items on issuance of satisfactory report the guarantee furnished by the "SUPPLIER" shall only be in the nature of security for performance of the contract and the "BUYER" shall not be precluded from claiming any amount in excess of the sum mentioned in the guarantee by way of damages for breach of contract.

28. ARBITRATION

In case of any dispute and difference which may arise in connection with the execution of this contract, shall be referred for adjudication to two arbitrators one to be nominated by each party by "SUPPLIER" and the "BUYER" who before entering upon the reference shall appoint an umpire by mutual agreement within one week of notice from either side or in case they do not agree a Judge of the Superior Court shall appoint an umpire. The arbitration proceedings shall be held in Pakistan and under Pakistan Law.

The decision of the arbitrators or the Umpire as the case may be shall be final, and binding on both the parties. The fees for arbitration shall be borne by the losing party and to be shared in case of settlement.
